

## GENERAL BOOKING CONDITIONS

### DEFINITIONS

#### **Tourist package**

A tourist package is an all-inclusive trip that includes the use of an unstaffed boat capable of navigating in open seas with accommodation on board.

The boat is being rented by the organiser and will be delivered by the owner to the client after identification on the basis of the information provided by the organiser, signing of a handover report, and payment of a deposit.

The tourist package, in addition to the use of the boat, includes additional services chosen in the negotiation phase, for example: outboard motor for the tender; additional linen, airline flights, transfers, hotels, restaurants, insurance, etc.. The customer, upon arrival at the port where the boat will be delivered, will be assisted in dealing with the owner by the organiser's staff, who will also provide any tourist information useful for the best enjoyment of the holiday.

#### **All-inclusive trip**

An all-inclusive trip is defined in Swiss Federal Law of 18 June 1993 on all-inclusive travel (Federal Law Gazette 944.3), i.e. in accordance with Article 1, Paragraph 1, as the prearranged combination of at least two of the following services, if offered at a package price, lasting for more than 24 hours or including an overnight stay: transport; accommodation; other tourist services not ancillary to transport or accommodation and constituting a significant part of the overall service.

#### **Organiser**

**PRIVATE TRAVEL SA**, Castel San Pietro, Via Piancorella 2, 6873 Corteglia, Switzerland, registered with the Trade Register Office of the Canton of Ticino with number CHE-101.088.966 is the exclusive organiser and seller of the tourist package.

#### **Intermediary**

This is the entity chosen by the customer that contacts the organiser to buy the tourist package.

#### **Customer**

The customer is the beneficiary of the tourist package.

#### **Owner**

The owner is the entity that has put the boat at the disposal of the organiser, as resulting from the boat documents.

### PRE-CONTRACTUAL INFORMATION

#### **Negotiation phase**

In the negotiation phase, the customer, directly or through an intermediary, verifies whether the organiser can provide the desired services.

#### **Contractual phase**

The contractual phase starts after the negotiation phase: the customer, after having secured the availability of the organiser (including through an intermediary) will receive from the organiser (including through the intermediary) a booking proposal of the requested services, including payment conditions.

#### **Place of stipulation of the sales contract**

The place of stipulation of the contract is the headquarters of the organiser, namely Castel San Pietro, Via Piancorella 2, 6873 Corteglia, Switzerland.

#### **Time of stipulation of the sales contract**

The contract is considered stipulated only at the time of payment of the deposit as requested by the organiser, including through an intermediary.

#### **Payment**

All payments must be made by bank transfer to the account of Private Travel SA
